- 2.1 Identify the type of laminate/ film provided
 - A. Forced Entry Resistance Safe Haven Defense's smash (SW450)
 - B. Bullet Resistance- Save Haven Bullet resistant (SW440BR)

Safe Haven Defense capabilities include the manufacture and application of a proprietary laminate to existing one quarter inch (1/4) or (3/8) glass in order to render a handgun ballistic, riot/burglar, and smash protection levels. One half (1/2) inch glass is required for rifle protection. The protection levels enable your students, staff and employees time, in which to escape threats, summon assistance, or to better survive an armed attack. When your buildings are not occupied, the resistance levels deter immediate entry through treated glass doors or windows, thus limiting further damage and destruction to property.

The laminate application is a fraction of the cost as compared to replacing existing glass with a thicker glass capable of resisting trauma from heavy blunt instruments, or for bullet resistance. A thicker replacement glass installation usually requires modifications of window frames and substructures to accommodate the added weight of the denser glass. Further, our smash level film laminate is 15 MILs in thickness, double the thickness of most competitor film/laminates.

Safe Haven Defense's smash (SW450), riot/burglar (SW440RC), and bullet resistant (SW440BR) laminates are applied on site to the interior of existing windows which offers critical deterrence against forced entry and active shooter incidents. No special modifications or retrofitting to existing structures are necessary.

c. Situations that best support installing bullet resistant film are those where this protection level is required to protect people from serious imminent threats by firearms or other deadly weapons. Examples may include, access control employees providing entry and access into the inner office areas of an organization, glass doorways into individual offices or classrooms, or into safe rooms designated by policy.

Offices within buildings having windows facing a streetway, or open shared area, may best be suited for bullet resistant film due to the potential of firearms being used from outside of the window and firing through the window at a distance.

4.1 & 4.2

Safe Haven Defense warrants their professionally installed SHD brand Security Laminates against the defects in manufacture or materials when the product is installed by a SHD installer in accordance with manufacturers installation procedures and applicable laws. The smash, riot/burglary control levels and bullet resistant laminates are warranted by a ten (10) year limited warranty period, against fading, peeling, cracking, adhesive failure, and delamination. The (SW440) Bullet resistant laminate, requires an inspection at seven (7) years in order to verify that the protective layer has not been compromised or damaged by human means or trauma objects. If acceptable the warranty is extended for the full ten (10) year period.

If the product does not conform to the warranty described, SHD will appoint an installer to remove the original laminate and apply new SHD laminate. SHD will cover the reasonable labor charges involving the removal of the original laminate and reinstallation of new laminate


