Consultant firms are reminded that as mandated by Arizona Revised Statutes § 41-4401, Maricopa is prohibited from awarding a contract to any contractor who fails, or whose subcontractors fail, to comply with the requirements to verify the employment eligibility of their employees through the <u>Federal E-verify system</u>. Note this also applies to all subcontractors and sub-consultants that you may use for this work.
